Esteemed House and Senate Committee Members,

We are writing on behalf of many United States citizens to request that an investigation be conducted into ties between a non-profit foundation, its parent pharmaceutical company, several panel and advisory committee members and the foundation's apparent takeover of the United States Government and the lives of the American People. We filed an initial complaint with the Senate Finance Committee on February 17, 2010 under the Whistleblowers Act. Twenty-one people from nine different states filed the complaint. To date, we've heard nothing. We subsequently forwarded our complaint to the House Committee on Oversight and Government Reform. Since the filing of that complaint, we've discovered even further evidence of apparent corruption. The Robert Wood Johnson Foundation, as **a non profit**, has imbedded themselves in the Federal Government, paying other non-profits to push for laws from which the Robert Wood Johnson Foundation and its parent pharmaceutical company, Johnson & Johnson, financially profit, as will be outlined in the complaint.

In 1996, the first Clinical Guideline on Tobacco Use Dependence and Treatment was written. In 2000, the Guideline was updated and was again updated in 2008.

This Guideline was written for physicians and clinicians to use when treating tobacco users. The 2008 Guideline directs physicians to strongly advocate *all* patients to quit smoking. The guideline recommends counseling and pharmacotherapy: Nicotine Replacement Therapy (Products). The Guideline also outlines how it has asserted pressure, through many organizations, for insurance companies and Medicaid to pay for NRT - the optimum word being "replacement". The goal of *Healthy People 2010* is for 100% coverage for nicotine replacement products. (*see highlights of the 2008 Guideline - Appendix 1*) The Guideline states that seven "first line medications" are listed for treatment: 2 by prescription and 5 over-the-counter.

Not only are doctors directed to push the drugs (NRT) but they're now being told that they can use "combinations" of NRT and that their use can be extended for long periods of time as NRT. The Guideline states "This is because, unlike smoking, these medications do not (c) produce strong dependence. Finally, it should be noted that the medication treatment that produced the largest effects on abstinence rates, of those analyzed, involved long-term nicotine patch therapy + ad libitum NRT (Table 6.26)." - Page 126 of the 2008 Guideline.

ROBERT WOOD JOHNSON FOUNDATION'S FINANCIAL ROLE IN TOBACCO CONTROL, THE GUIDELINE AND FDA ADVISORY PANEL ON TOBACCO

As outlined in our previously filed complaints, the Robert Wood Johnson Foundation (RWJF) was created by the founder of Johnson & Johnson, funded by millions of shares of JnJ stock. When the first guideline was written in 1996, RWJF owned 71,657,994 shares of JnJ common stock, fair market value \$3.564,985,000 (computes to \$49.75 avg. value per share). (see Appendix 4)

December, 2006, the purchase of Pfizer Health Care to Johnson & Johnson was finalized which gave Johnson & Johnson Nicorette, sewing up a monopoly of the five over-the-counter products outlined in the Guideline (see Appendix 2). Coincidentally, Ohio's smoking ban was voter approved in November, 2006. RWJF funded Tobacco-Free Ohio with \$2.87 million¹. J&J had inside information on smoking bans since THEIR Foundation was the funder. In 2006, RWJF owned 55,983,308 shares of J&J common stock, fair market value \$3,807,684 (computes to \$68.03 per share). Gains on sales of stock \$460,441,000.

RWJF's publications *Taking on Tobacco; the Robert Wood Johnson Foundation's Assault on Tobaccoⁱⁱ(pgs 5 &6 outline grants)* and *The SmokeLess States Program*ⁱⁱⁱ outline the millions of dollars in "grants" to lobby for laws that push the need for and payment of J&J products. It outlines how RWJF funds and even creates advocates, such as Tobacco-Free Kids^{IV} (funded with an initial \$84,000,000 in grant money). Under President Obama, William Corr from Tobacco-Free Kids, was appointed to Health and Human Services which oversees the FDA.

In 2010, the Tobacco Products Scientific Advisory Committee was created within the FDA which regulates tobacco^v. It is comprised of 12 members, 1 from the FDA, 3 from the tobacco industry and 8 other "experts". Excluding the FDA employee and 3 representatives of the tobacco industry, each and every member of the Committee has received funding from the Robert Wood Johnson Foundation.

Of the 27 members of the 2000/2008 Guideline Panels, 17 received direct funding from RWJF funding while 3 indirectly received funding (their university or organization received RWJF funding). Hardly an unbiased panel who push the products of Johnson & Johnson while increasing the bottom line of the non-profit from whom a majority receive funding.

Since 1974, the Robert Wood Johnson Foundation has paid salaries for 238 fellows who have been given "free of charge" to 278 Congressional members (134 Democrats, 63 Republicans) and committees, agencies, Speaker of the House Pelosi, First Lady Obama, etc. That's upwards of \$39 million RWJF has paid to sponsoring organizations to place fellows with influential people in Congress and on very influential committees. At today's RWJF fellow salaries, Congress would have received \$39.27 million in free labor. Are those claimed as contributions? The American public will never know the influence these fellows had in their roles in Congress, etc.

The problems with over-the-counter nicotine replacement products

A look at the nicotine replacement products being pushed by the Guideline Panel shows: (PLEASE see Appendix 3 for sources)

- Cancer risk of nicotine gum and lozenges higher than thought
- Minors able to buy nicotine replacement therapy products
- Nicorette users highly addicted to Nicorette gum
- Health issues association with Nicorette widely unknown and not conveyed to public as warning
- NRT patch has a 98.4% failure rate for quitting long term
- Nicotine gum addiction now treated with Chantix
- The neglected scientific evidence that nicotine replacement therapy is over-promoted since most ex-smokers quit unassisted
- Removed from the ACS' website, a 2003 report that shows more people guit smoking unassisted (see Appendix 3)
- Millions of dollars in Federal Stimulus money has been given for NRT products^{vi}
- No FDA or physician monitoring of over-the-counter NRT usage, addiction or health issues.
- Many people have traded the addiction to the nicotine in cigarettes to the addiction of nicotine in the gum

Because nicotine replacement is widely available as over-the-counter medication, there is little to no control over its purchase, use, addiction and health problems. Doctors are unaware of the addiction and serious health problems posed because it is not controlled through prescriptions. The Guideline Panel is all consumed with the problems of tobacco while not following up on the addictive component, nicotine, in the products they push. There needs to be studies done on NRT and NRT should ONLY be prescribed by a physician who can monitor the addiction, etc.

ROBERT WOOD JOHNSON FOUNDATION'S ROLE IN OBESITY

We would be remiss if we did not point out the same behavior-control-for-profit being pushed by the Robert Wood Johnson Foundation's war on obesity. RWJF has committed half a billion dollars in "grant" money for Childhood Obesity.

RWJF has pushed to taxing soda pop with sugars (not pop in general, just pop with sugars). (see Appendix 10) In fact, RWJF has modeled the war on sugar using their Tobacco Control footprint.

Johnson & Johnson owns Splenda, the nation's #1 sugar substitute^{viii}. Splenda is made by the McNeil Corporation for Johnson & Johnson.

Johnson & Johnson owns EthiconEndo is "the only company that supports all three of the primary bariatric surgeries – gastric banding, gastric bypass, sleeve gastrectomy^{ix}

Following the J&J/RWJF model on grant giving for studies that "prove" the need for laws from which J&J/RWJF profit, this Wall Street Journal article^x states:

"The cost of the most common type of weight-loss surgery, which typically runs between \$17,000 and \$26,000, is offset within two to four years by medical cost savings, according to a new study. The findings, published in the September issue of the American Journal of Managed Care, may increase pressure on health-insurance companies to cover gastric bypass surgery. Some insurance plans specifically exclude weight-loss surgery, despite medical evidence of its effectiveness as a treatment not just for obesity, but also for related conditions including diabetes, high blood pressure and sleep apnea.

"The most cost-effective treatment for obesity is bariatric surgery. If you do that, within two to four years, you will get your money back," said the study's lead author, Pierre-Yves Crémieux, a health economist and principal at Analysis Group Inc., an economic consulting firm in Boston. "We have identified the break-even point for insurers," he added.

Some policy makers and analysts are likely to question the findings because the study was paid for by Johnson & Johnson's Ethicon Endo-Surgery unit, a maker of surgical devices and instruments used in weight-loss surgery. Dr. Crémieux said he stands by the study's integrity and added that the company "has been totally hands off."

The study^{xi} in the article admits it does not take several things into consideration in the cost savings: quality-of-life and length-of-life benefits

SUMMARY

We allege:

Johnson & Johnson has the market cornered on over-the-counter nicotine replacement products. That's a monopoly and that is in violation of the Sherman Act. (The Sherman Antitrust Act (Sherman Act, July 2, 1890, ch. 647, 26 Stat. 209, 15 U.S.C. § 1–7) requires the United States Federal government to investigate and pursue trusts, companies, and organizations suspected of violating the Act.)

Johnson & Johnson and their RWJF have engaged in legislative rent seeking (In economics, **rent seeking** occurs when an individual, organization or firm seeks to earn income by capturing economic rent through manipulation or exploitation of the economic or political environment, rather than by earning profits through economic transactions and the production of added wealth.)

Johnson & Johnson had insider knowledge into laws that allowed them to purchase a division of Pfizer to secure a monopoly of the over-the-counter nicotine replacement products. Their own non-profit pays others to lobby for these laws. This results in artificial inflation of their stock.

Johnson & Johnson and their RWJF have duped the US and State governments and insurance companies out of billions of dollars for nicotine replacement products that are addicting users to the products. In addition, some of these products simply do not work (the nicotine patch). RWJF has used their grant money to have others lobby to have medicare and insurance companies pay for their products. The Tobacco Use Prevention Guideline Panel is laden with "experts" who have all profited from money given to them from RWJF in the form of grants, have obtained powerful seats on commissions and councils and who continue to reap the rewards. The FDA Tobacco Advisory Panel members, except 3 tobacco industry persons and 1 federal government employee, have ALL received money from RWJF. RWJF has paid MILLIONS of dollars in salaries to place their fellows with influential congressional members and committees. This is a travesty. This is a violation of the RICO Act and the False Claims Act.

Federal stimulus money being given for nicotine replacement products! How does this create jobs? It just profits Big Pharma.

We have asked for an investigation previously into the allegedly illegal actions of Johnson & Johnson and their highly profitable "non" profit. Not only do the individuals whose names are contained in this letter demand an investigation, so do the 1942 signatures on this petition^{xii}.

There are many who should be investigated besides J&J and RWJF. They all profited from J&J's and RWJF's marketing plan.

Appendix 1

2000 & 2008 Clinical Practice Guideline For Physicians and Clinicians Tobacco Use Dependence and Treatment

The original guideline was published in 1996. It was updated in 2000 and again in 2008. The 1996 publication was based on 3,000 articles. The 2000 guideline included an additional 3,000 while the 2008 update *screened* an additional 2,700 articles.

These guidelines are intended for physicians and clinicians to strongly advise every patient who smokes to quit (because physicians advising patients to quit increases abstinence rates. Nonphysician clinicians are believed to increase quit rates). The 2008 Guideline states "The update was written to include new, effective clinical treatments for tobacco dependence that have become available since the 2000 Guideline was published."

The updated Guideline was sponsored by a consortium of eight Federal Government and nonprofit organizations: the Agency for Healthcare Research and Quality (AHRQ); Centers for Disease Control and Prevention (CDC); National Cancer Institute (NCI); National Heart, Lung, and Blood Institute (NHLBI); National Institute on Drug Abuse (NIDA); American Legacy Foundation; Robert Wood Johnson Foundation (RWJF); and University of Wisconsin School of Medicine and Public Health's Center for Tobacco Research and Intervention (UW-CTRI).

The updated Guideline was "sponsored" by 5 federal agencies, ALF which was created by the Master Settlement Agreement (whose funding depends on the MSA), UW-CTRI and RWJF.

UW-CRTI claims^{xiii} " Since 1998, 25 researcher/managed care organization teams have undertaken more than \$7 million of research in a program directed by UW-CTRI and funded by the Robert Wood Johnson Foundation. This research looks at changes in healthcare systems that can be made to promote smoking cessation."

Other than government agencies, ALF (who also has received grant money from RWJF), UW-CTRI (heavily funded by RWJF) and RWJF "sponsored" these guidelines.

There are 10 key recommendations of the updated Guideline. Of those 10, notable are:

The overarching goal of these recommendations is that clinicians strongly recommend the use of effective tobacco dependence counseling and medication treatments to their patients who use tobacco, and that health systems, insurers, and purchasers assist clinicians in making such effective treatments available.

- 1. Tobacco dependence is a chronic disease that often requires repeated intervention and multiple attempts to quit. Effective treatments exist, however, that can significantly increase rates of long-term abstinence. (notice they do NOT say quit)
- 2. It is essential that clinicians and health care delivery systems consistently identify and document tobacco use status and treat every tobacco user seen in a health care setting.
- 3. Tobacco dependence treatments are effective across a broad range of populations. Clinicians should encourage every patient willing to make a quit attempt to use the counseling treatments and medications recommended in this Guideline.
- 6. Numerous effective medications are available for tobacco dependence, and clinicians should encourage their use by all patients attempting to quit smoking—except when medically contraindicated or with specific populations for which there is insufficient evidence of effectiveness (i.e., pregnant women, smokeless tobacco users, light smokers, and adolescents).

Pg. 2 of the 2008 Guideline states:

- " Seven U.S. Food and Drug Administration (FDA)-approved medications for treating tobacco dependence are now available, and new evidence has revealed that particular medications or combinations of medications are especially effective."
 - 7 medications have been approved (Johnson & Johnson medications)
 See Table 1
 - ...or combinations (of medications) are especially effective

Insurance companies and Medicaid coverage for NRT products:

2008 Guideline, pg. 2

The scant dozen years following the publication of the first Guideline have ushered in similarly impressive changes. In 1997, only 25 percent of managed health care plans covered any tobacco dependence treatment; this figure approached 90 percent by 2003,16 although this increased coverage often includes barriers to use. Numerous states added Medicaid coverage for tobacco dependence treatment since the publication of the first Guideline so that, by 2005, 72 percent offered coverage for at least one Guideline recommended treatment. Finally, Medicare, the Veterans Health Administration, and the United States Military now provide coverage for tobacco dependence treatment.

If all smokers covered by state Medicaid programs quit, the annual savings to Medicaid would be \$9.7 billion after 5 years. (how much would have been spent prescribing NRT over and over again, using multiple therapies, until all smokers quit? What exactly is the average cost of NRT products for one ex-smoker to stay quit?

Although substantial progress has been made since the publication of the first Guideline in 1996,1,216-218 neither private insurers nor state Medicaid programs consistently provide comprehensive coverage of evidence-based tobacco interventions.206,214,219 Findings such as these resulted in the Healthy People 2010 objective: Increase insurance coverage of evidence-based treatment for nicotine dependency to 100 percent.

When NRT products fail

Modern approaches to treating tobacco use and dependence should reflect the chronicity of tobacco dependence. A chronic disease model recognizes the long-term nature of the disorder with an expectation that patients may have periods of relapse and remission.

Most smokers who ultimately quit smoking <u>experience episodes of relapse</u> on the way to success. <u>Relapse should not discourage the</u> clinician or the tobacco user from renewed quit attempts.

2008 Guideline articles screened

It is important to note that the article-screening criteria were updated for the 2008 Guideline update. Additionally, articles were screened for relevance to safety, economic, or health systems issues. As a result of the original and update literature reviews, more than 300 articles were identified for possible inclusion in a meta-analysis, and more than 600 additional articles were examined in detail by the Panel. These latter articles were used in the formulation of Panel recommendations that were not supported by meta-analyses.

Combination Medications

2000 Guideline. Recommendation: Combining the nicotine patch with a self-administered form of nicotine replacement therapy (either the nicotine gum or nicotine nasal spray) is more efficacious than a single form of nicotine replacement, and patients should be encouraged to use such combined treatments if they are unable to quit using a single type of first-line medication. (Strength of Evidence = B)

2008 Guideline Update. Recommendation: Certain combinations of firstline medications have been shown to be effective smoking cessation treatments. Therefore, clinicians should consider using these combinations of medications with their patients who are willing to quit. Effective combination medications are long-term (> 14 weeks) nicotine patch + other NRT (gum and spray), the nicotine patch + the nicotine inhaler, and the nicotine patch + bupropion SR. (Strength of Evidence = A)

Extended Use of Medications

For some patients, it may be appropriate to continue medication treatment for periods longer than is usually recommended. Results of the inclusive meta-analysis indicated that long-term patch and gum use are effective. Evidence indicates that the long-term use of gum may be more effective than a shorter course of gum therapy. (Table 6.26). The Lung Health Study, of almost 4,000 smokers with evidence of early COPD, reported that approximately one-third of long-term quitters still were using nicotine gum at 12 months, and some for as long as 5 years, with no serious side effects. Other studies also have found that, among patients given free access to nicotine gum, 15 to 20 percent of successful abstainers continue to use the gum for a year or longer. Thus, it may be that certain groups of smokers may benefit from long-term medication use. Although weaning should be encouraged for all patients using medications, continued use of such medication clearly is preferable to a return to smoking with respect to health consequences. This is because, unlike smoking, these medications do not (a) contain non-nicotine toxic substances (e.g., "tar," carbon monoxide, formaldehyde, benzene); (b) produce sharp surges in blood nicotine levels; and/or (c) produce strong dependence.

Of the 4 over-the-counter smoking cessation categories, <u>Johnson & Johnson has products in EACH of these categories</u>. In fact, <u>MOST of these categories have Johnson & Johnson ONLY products</u>.

Why does the guideline include clinical trial drugs in this physician/clinician guide? These drugs are NOT approved by the FDA for smoking cessation!

What they Don't Tell You About Nicotine Replacement Products

'Cancer risk of nicotine gum and lozenges higher than thought'xxiii

Scientists have discovered a link between mouth cancer and exposure to nicotine, which may indicate that using oral nicotine replacement therapies for long periods could contribute to a raised risk of the disease. A study funded by the Medical Research Council, led by Muy-Teck Teh, of Queen Mary, University of London, has found that the effects of a genetic mutation that is common in mouth cancer can be worsened by nicotine in the levels that are typically found in smoking cessation products.

The results raise the prospect that nicotine, the addictive chemical in tobacco, may be more carcinogenic than had previously been appreciated. "Although we acknowledge the importance of encouraging people to quit smoking, our research suggests nicotine found in lozenges and chewing gums may increase the risk of mouth cancer," Dr Teh said.

Study Published in the Public Library of Science - Medicine (PLoS Medicine)

Health authorities should emphasize the positive message that the most successful method used by most ex-smokers is unassisted cessation, despite the promotion of cessation drugs by pharmaceutical companies and many tobacco control advocates. The dominant messages about smoking cessation contained in most tobacco control campaigns, which emphasize that serious attempts at quitting smoking must be pharmacologically or professionally mediated, are critiqued in an essay in this week's *PLoS Medicine* by Simon Chapman and Ross MacKenzie from the School of Public Health at the University of Sydney, Australia. This overemphasis on quit methods like nicotine replacement therapy (NRT) has led to the "medicalisation of smoking cessation," despite good evidence that the most successful method used by most ex-smokers is quitting "cold turkey" or reducing-then-quitting. Reviewing 511 studies published in 2007 and 2 008 the authors report that studies repeatedly show that two-thirds to three-quarters of ex-smokers stop unaided and most ex-smokers report that cessation was less difficult than expected.

The medicalisation of smoking cessation is fuelled by the extent and influence of pharmaceutical support for cessation intervention studies, say the authors. They cite a recent review of randomized controlled trials of nicotine replacement therapy (NRT) that found that 51% of industry-funded trials reported significant cessation effects, while only 22% of non-industry trials did. Many assisted cessation studies—but few if any unassisted cessation studies—involve researchers who declare support from a pharmaceutical company manufacturing cessation products.

The authors conclude that "public sector communicators should be encouraged to redress the overwhelming dominance of assisted cessation in public awareness, so that some balance can restored in smokers' minds regarding the contribution that assisted and unassisted smoking cessation approaches can make to helping them guit smoking."

This website, AskAPatient.com^{xxv}, asks users of different drugs, medicines, etc. to post their comments about products. We were shocked when we read of the addiction to Nicorette gum and lozenges. We were even more shocked to read of the extreme health problems associated with the addiction. There are hundreds of comments. These are a few of the comments from the latest page:

"Major dental problems which require \$6,000 of work all on the lower part of my mouth. It is totally rotting my gums. I could not figure out why I had such a bad dental report since I use a sonic care toothbrush and floss daily."

"Nicorette is highly addictive. The tendency is to take more and more. There is no way out of this medicine. Leave your hands off this drug. It is expensive and each year the price is rising. I'm addicted to Nicorette more the 8 years and I see no way out of my dependents"

"It is one of the most addictive things I have ever tried. It forced me to get addicted to Loritabs to stop the pain in my mouth and teeth. Now I am fighting two addictions."

"I smoked for 20 years. I tried to quit several times. The nicroette did help me to quit smoking but I can't seem to quit the nicroette."

"I started using to quit black n milds after 6 years of smoking. From the very first day and the first piece I started feeling a horrible burning in my throat. Thinking maybe I chewed too much I ignored it. I chewed 3 pieces the first day and 1 the next 2 days. My lymph nodes are swollen I keep coughing it hasn't gotten any better...yesterday my right ear started hurting terribly and my tongue feels as though it is VERY BADLY BURNT. I couldn't figure out how or where I could have developed an ear infection and realized after reading these comments that nicorette is to blame. I can't even eat without wanting to cry. **PLEASE IF YOU CARE ABOUT YOURSELF STOP TAKING THIS**."

"have only been chewing the gum for 45 days. i quit smoking but i started noticing that gobs of hair were falling out in the shower and when i was brushing my hair. it has progressively gotten worse and now my once very thick hair is much thinner. after only 45 days! i am quitting the qum immediately but am having anxiety about trying to quit--almost as much as when i quit smoking."

"I finally quit nicorette after 20+ years. I was scared off the drug when I was diagnosed with bone loss in the area of my mouth where I used to "store" the gum. As a result, I have had to have my teeth pulled, followed by bone grafts and implants. The rest of my teeth are healthy... it was just in the area where the nicorette was placed for so many years. All of this was a high price to pay for the years of chewing. I hope others will read this and consider quitting."

"I'm just as addicted to the gum as I was to cigarettes. I haven't saved any money since I spend as much on the gum as I did on cigarettes. The only difference is the gum doesn't stink. And cigarettes don't make my skin itch."

"Have been chewing gum since I was 27, originally to quit smoking (1 pack/day) but 19 years later am still chewing it! Over the years I have suffered with severe hair loss since about age 27! Am now 46 and have only 50% of my hair left! Some people have suggested menopause

could be the cause for the hair loss - but not when I was 27! That's when my hair started to fall out - and that's when I began to constantly chew this qum! I replaced my addiction for cigarettes with an addiction to nicotine qum!"

"It's really difficult to stop using! It's nico-crack! Stay away if you can. I started doing some research and even the FDA doesn't have any information on most of the nicotine products. Most of the studies I found were funded by the same companies that make the gum. I'm deliberately being mislead."

"STAY AWAY FROM THIS STUFF! Super addictive, causes severe anxiety and depression. Really messes with my sinuses and causes them to swell. This crap is probably worse for you then"

"Totally and utterly addictive. I had stopped smoking three times in the past without help - for periods up to two years - so no great problem cutting down the cigarettes. Now use around 20-30 strips of 4mg Nicorette per week and even the thought of not having them brings on extreme anxiety."

"Mercifully Nicorette did help me quit a heavy cigarette addiction. However, I am hooked on the gum. Recently I've been chewing the cinnamon flavored Nicorette and noticed the mouth and tongue problems. I think it has something to do with the flavor. However, it has not been great to trade one addiction for another. It is like chewing tobacco--what sort of oral harm can this bring about? One thing I've found is that chewing the original flavored Trident gum helps with Nicorette cravings--at least for me. I am getting off Nicorette as of now."

"This stuff is horrible. If you are smart enough to research it before taking it (unlike me) please heed my advice and stay away from it unless you want to be completely bald. If your'e already bald have a blast with it."

A few months ago, I noticed a lump on my gum (in the area that I used to store the nicorette). I went to a dentist, periodontist, endodontist and oral surgeon. I ended up having multiple bone grafts because there was no bone left in that area. If the latest graft is not successful, I will need to have my healthy tooth removed and get an implant. I believe these problems are a result of the \$300+/month habit I had for so long. I hope my experience helps someone that wants to break this horribly addicting drug! I also hope Nicorette is discontinued... I feel I would have been better off smoking!"

Minors able to buy nicotine replacement therapy products

CHICAGO – Although over-the-counter nicotine <u>replacement</u> therapy products like gum and patches have labeling indicating that they are not for sale to minors, these products were successfully purchased by a minor in more than 80 percent of purchase attempts, according to an article in *The Archives of Pediatrics & Adolescent Medicine*, one of the JAMA/Archives <u>journals</u>.

According to the article, an estimated 28.5 percent of high school students smoke cigarettes and more than half try to quit each year. Public health guidelines recommend that health care providers counsel adolescents to stop smoking, and to try nicotine replacement therapy (NRT, including gum, patches, etc.) to help in smoking cessation. Many NRT products are sold over-the-counter, but the labeling on these items indicates that they should not be sold to anyone under 18 years.

Karen C. Johnson, M.D., M.P.H., from The University of Tennessee Health Science Center, Memphis, and colleagues investigated the ability of a minor to purchase over the counter NRT products.

The researchers identified 165 stores (retail, drug stores and grocery stores) in Memphis that sold over the counter NRT products. A 15-year-old girl visited the stores and attempted to buy NRT. She was instructed not to lie about her age, and carried no identification indicating her age. The minor was accompanied by an adult supervisor who entered the stores separately to observe the purchase attempts. The supervisor had no direct contact with the minor or the sales clerks.

In 81 percent of purchase attempts, the minor was able to purchase NRT. She was not questioned about her age in 79 percent of purchase attempts. The researchers also found that if the clerk asked the girl's age, she was much less likely to be allowed to buy NRT.

"Our study demonstrates that most purchases of NRT were obtained by a minor buyer without proof of age, despite warnings printed on the product," the authors write. "Given these findings, we conclude that the FDA-approved product labeling has little effect on actual sales practice. However, health practitioners recommending NRT to adolescent smokers attempting to quit should consider potential barriers to youth access."

Editorial: Nicotine Replacement Therapy for Teenagers

In an accompanying editorial, William P. Adelman, M.D., of the National Naval Medical Center, Bethesda, Md., writes that adolescents may not use tobacco for the same reasons adults do: "Although a proportion of adolescent smokers meet subjective criteria for nicotine dependence, it is not necessarily nicotine that commits the adolescent to smoke as much as the unique behavioral and social factors associated with smoking at this developmental stage," Dr. Adelman writes.

He also notes that because adolescents may smoke more for social reasons than because they are addicted, NRT does not work very well in adolescents. "These behavioral and social influences on smoking are not altered with NRT, and NRT predictably fails as an effective aid in tobacco use cessation," he writes.

Dr. Adelman concludes: "Nicotine replacement therapy is not a primary therapy for adolescent smoking cessation. Improving access to NRT for teens is unlikely to improve cessation rates except perhaps in carefully selected individuals, under supervision by a physician, within the context of a smoking cessation program. As new, more rigorous and comprehensive studies are executed and their findings published, our understanding of this problem and our approach to the adolescent tobacco user will evolve."

1. An Effective Intervention?

It appears to me that the conclusions of this paper are highly slanted. With a long-term smoking cessation percentage of only 1.6%, one can hardly call NRT treatment an "effective" intervention in this situation. Even though the 1.6% abstinence rate is better than the 0.4% achieved with placebo, how can one call the 1.6% success rate with NRT to be "effective?"

In fact, the logical conclusion from this paper is that NRT was a dismal intervention. The overwhelming majority of smokers - 98.4% - failed to achieve long-term sustained abstinence with NRT treatment.

Given the presence of a financial conflict of interest with a pharmaceutical company that manufactures nicotine replacement products, it certainly has the appearance that this conflict has biased the interpretation of the findings and the study conclusion.

I can't quite think of another intervention for which a 98.4% failure rate would be considered a success.

Abstract

Introduction: The buccal absorption of nicotine replacement therapy is a part of the treatment to quit smoking. In some cases, this use could last more than six months.

Methods and Results: We report the case of a woman, former smoker, who took nicotine gums for over five years and was treated successfully with Varenicline during six months according to the recommended posology.

Discussion: Varenicline, a partial alpha 4 beta 2 nicotinic receptor agonist, could be a solution to help former smokers to stop long-term use of nicotine gums or lozenges. Further studies will be necessary to confirm this result.



The Strategic Dialog on Tobacco Harm Reduction (the Dialogue) IXXXVIII

This group of experts, who have devoted their careers to reducing tobacco use, met in a two-year process they called The Strategic Dialogue on Tobacco Harm Reduction (the Dialogue). Their vision: a world in which virtually no one uses cigarettes. Dialogue participants concluded that realizing that vision would have a profound impact on reducing death and disease from tobacco use.

The Dialogue process was led by Dorothy Hatsukami, Ph.D., director of the University of Minnesota's Tobacco Use Research Center and Masonic Cancer Center's Cancer Control and Prevention Programs, and Mitchell Zeller, a former associate commissioner of the U.S. Food and Drug Administration and currently a health policy expert with Pinney Associates.

The Dialogue members' recommendations appear in the online version of the peer-reviewed journal <u>Tobacco Control</u>. Their report recommends various ways to regulate tobacco products based on public health needs. It also recommends helping tobacco users who are unable or unwilling to quit to shift to the least harmful nicotine products.

Study: Tobacco Industry Prevention Ads Aimed at Teens Have No Effect on Youth Smoking xciv Study finds that some tobacco industry sponsored prevention ads targeted at parents may increase likelihood **of** teen smoking

Published: October 31, 2006 Washington, D.C.

Televised ads sponsored by tobacco companies and targeted at youth do not change teen smoking outcomes, according to a study published online today by the *American Journal of Public Health*. Results from the study also show that tobacco industry-sponsored prevention ads intended for parents may have harmful effects on older youth, lowering youth perceptions about the danger of smoking and increasing their likelihood of smoking.

This study is the first to examine how youth are affected by parent-targeted ads sponsored by the tobacco industry. Among 10th and 12th graders, higher exposure to parent-targeted ads was, on average, associated with lower perceived harm of smoking, stronger approval of smoking, stronger intentions to smoke in the future, and a greater likelihood of having smoked in the past 30 days. The National Cancer Institute, the National Institute on Drug Abuse and the Robert Wood Johnson Foundation funded the study.

"This research provides the clearest evidence to date that tobacco-sponsored ads don't work," said Melanie Wakefield, a UIC researcher and the study's lead author. "Tobacco-sponsored ads targeted at youth have no impact and those targeted at parents seem to have an adverse effect on students who are in their middle and later teenage years."

The fact that I ended up in the office of Senator Kennedy was particularly rewarding. I came into an office that was a churning health policy legislation factory, filled with eager and interesting folks and unceasing ideas. There were enough staff and fellows from various walks of the health world, that I was assigned a diverse portfolio of issues, but one which was dominated by issues in the area of mental health and substance abuse. The staff in the office gave me plenty of responsibility and authority to manage several of the issues in a fairly independent fashion. Although the working conditions were not unlike that of an upscale sweatshop, with antiquated and frustratingly slow computers and an abundance of noise and other distractions, it was an environment that was exciting, stimulating, and mutually supportive. We also had a steady stream of bright, energetic, and collaborative interns, who were able to take on some of the less interesting and more tedious tasks associated with some of our assignments.

It was a fascinating experience and a rather sobering one as well. For all my idealistic notions of progressive politics and my cynicism about the political establishment, I came away with a great respect for our governmental process, in spite of the obvious silliness, craven partisanship, and obscene corporate influence that pervades the place. Most of all, I came away with a sense of away and admiration for the many very dedicated and extremely hardworking folks who inhabit the Congress, the federal bureaucracies, and the lobbying world, even some of the Republicans. That isn't to say that there isn't an abundance of self-serving status seekers and slimy operators who are simply interested in short-term gains for themselves or their clients, because there is, especially now that the Bush administration has allowed political and personal power considerations to displace reasoned and meaningful discussions and policy-based decision making. There still are a lot of folks who care about this country, its people, its environment, and the process by which policies are made and implemented, and occasionally the good guys win, even when the victory comes in the form of a complicated compromise.

Introduction

Obesity rates among U.S. children, adolescents and adults have increased dramatically over the past four decades.1.2 Today, nearly one-third of all children and adolescents in the country—more than 23 million—are overweight or obese, and are therefore at greater risk for heart disease, type 2 diabetes and a host of other serious diseases.3.4 Rising obesity rates have motivated policy-makers to implement policies that can improve access to affordable, healthy foods and increase opportunities for physical activity in schools and communities across the country.

In the past decade, states and localities also have begun to consider taxing sugar-sweetened beverages (SSBs)—including sodas, sports drinks, sweetened tea, fruit drinks and punches, and other sweetened beverages—in order to generate revenue, reduce consumption of unhealthy beverages and promote public health.5

Research has shown that relatively large increases in taxes on cigarettes and other tobacco products are the single most effective policy approach to reducing tobacco use.6,7,8,9 Additionally, dedicating a portion of the revenues gained from such taxes to comprehensive tobacco control programs has led to further reductions in tobacco use among youth and adults.10,11,12

Although there are many significant differences between tobacco and SSBs, the tobacco example provides a model for how taxes can be used to promote public health. Emerging studies suggest that small taxes on SSBs are unlikely to affect obesity rates, but they can generate revenue that states can invest in improving public health. In addition, while there is only limited research on the impact of taxes on SSB consumption rates and related weight outcomes, existing research on the impact of prices on food-purchasing behaviors in general suggests that substantive taxes on SSBs could significantly affect consumption patterns and thereby have an impact on overweight and obesity rates. This brief provides an overview of the current research on the health impacts of SSB consumption, how food and beverage prices affect consumption and related weight outcomes, and the potential impact of both large and small SSB taxes.

Soda pop a factor in obesity^{ci}

This past June, a very troubling report on obesity was issued by the Trust for America's Health and the Robert Wood Johnson Foundation. The study found that adult obesity rates increased in 28 states in the past year. More than two-thirds of states (38) have adult obesity rates above 25 percent. Even more troubling, it was found that childhood obesity increased by 10 percent. In fact, 12 million children and adolescents are now considered obese.

An epidemic of this magnitude requires that policy makers address America's obesity problem right now. Perhaps the easiest way to start would be a significant consumption tax on soda and other sugary drinks much like the taxes on tobacco.

National Soda Tax Proposed^{cii}

Would a national tax on soft drinks be useful in fighting the war against obesity? A group of healthcare experts pushing the notion say a one cent-per-ounce tax on drinks with sugar could raise nearly \$15 billion for health initiatives.

Arkansas Surgeon General Joseph W. Thompson, MD, MPH, a pediatrician and director of the Arkansas Center for Health Improvement and the Robert Wood Johnson Foundation Center to Prevent Childhood Obesity, and an associate professor in the UAMS Colleges of Medicine and Public Health, is among the proponents for the controversial plan, which could mimic the state tax adopted in Arkansas in 1992.

"Federal, state, and local governments utilize tax policies to shape social goals and objectives, respond to threats, raise revenues for needed programs, and offer incentives for specific actions," he explained, pointing to a recent article in the *New England Journal of Medicine* that suggests a tax on soft drinks could help fight obesity. "The recent *NEJM* article highlighted the link between consumption of sugar sweetened beverages (SSBs) and obesity—the growing epidemic threatening our citizens and costing our nation hundreds of millions of dollars."
